Resolutions Taken:

1. Safety measures to guarantee campus free from Ragging.:

The Chairman has instructed the members of the Anti-Ragging committee to inspect the areas such as the food courts, bus parking area, canteen, library, etc., with the aim of ensuring that Aditya Pharmacy College should be free from any incidents of ragging.

2. Rosters of Responsibilities for Anti-Ragging Activity:

The chairman tasked the anti-ragging committee members by creating duty rosters for the Anti-Ragging squad in their respective departments and also submitting the duty rosters for the departmental squad in the prescribed format, which will be used to prepare the institute-level squad.

3. Any additional responsibilities authorized by the chairman of the committee:

- ✓ The principal instructed the office staff to display Anti-Ragging banners in every department, hostel, and canteen.
- ✓ The principal recommended that bus in-charges and faculty members traveling on student buses sit in the last rows to prevent ragging.
- ✓ The committee decided to conduct visits to both boys' and girls' hostels during the evening sessions, specifically from 06:30 PM to 08:30 PM, for a duration of one month after the commencement of regular college activities (offline) following the first-year admissions to the hostel.

AWARENESS PROGRAMME ON "ZERO TOLERANCE FOR RAGGING: FOSTER A SAFE LEARNING ENVIRONMENT"

An awareness program was conducted on "Zero Tolerance for Ragging: Foster a Safe Learning Environment" on 25-01-2025 at Seminar Hall for B. Pharmacy, Pharm. D & M. pharmacy Students. Around 102 students attend the seminar. The Programme began with the introduction of Chairman of Anti ragging committee Dr. D. Sathis Kumar. He emphasized the importance of maintaining a ragging-free environment and urged students to be vigilant and responsible. He reiterated that ragging has no place in the institution, as it goes against the very essence of education.

Mrs. Devi Avasarala, Panel Advocate, Prathipadu JCJ Court, was invited to speak about the definition of ragging and its various forms, Legal provisions under the Indian Penal Code (IPC) and the University Grants Commission (UGC) regulations. The speaker highlighted the consequences of ragging, including suspension, expulsion, and legal actions. Mrs. Devi Avasarala also explained the procedure for reporting ragging incidents, including anonymous complaints and the role of the Anti-Ragging Committee. The session was interactive, with students sharing their thoughts and experiences.

The Convener of Anti-Ragging Committee Mrs. G. Prasanthi addressed the students about psychological and emotional consequences of ragging. She explained how ragging could lead to long-term mental health issues, such as depression, anxiety, and even suicidal tendencies.

The program concluded with all participants taking a collective pledge to maintain a zero-tolerance stance on ragging and commit to upholding the values of respect, kindness, and inclusivity. The pledge emphasized the collective responsibility of students, faculty, and staff in creating a safe campus.

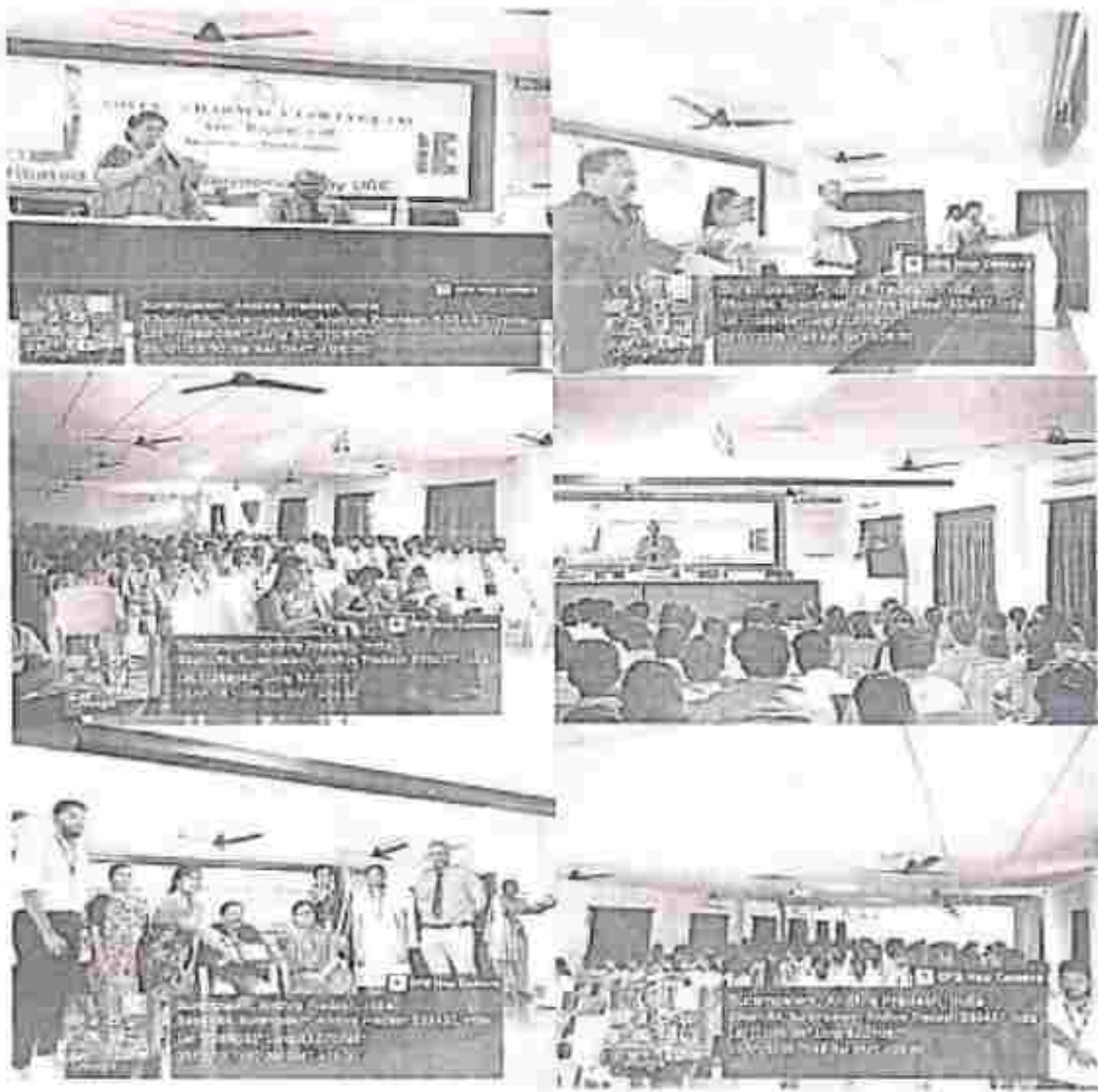

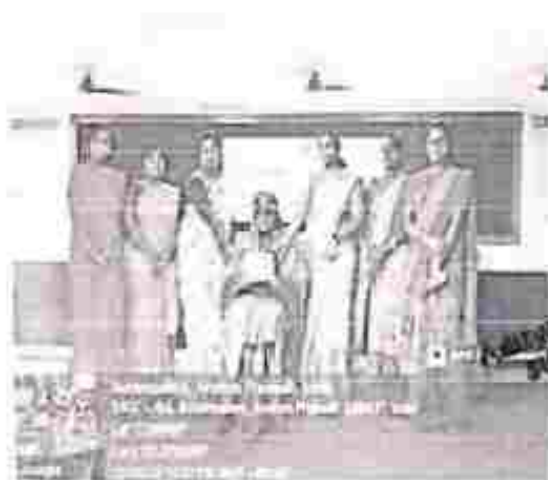

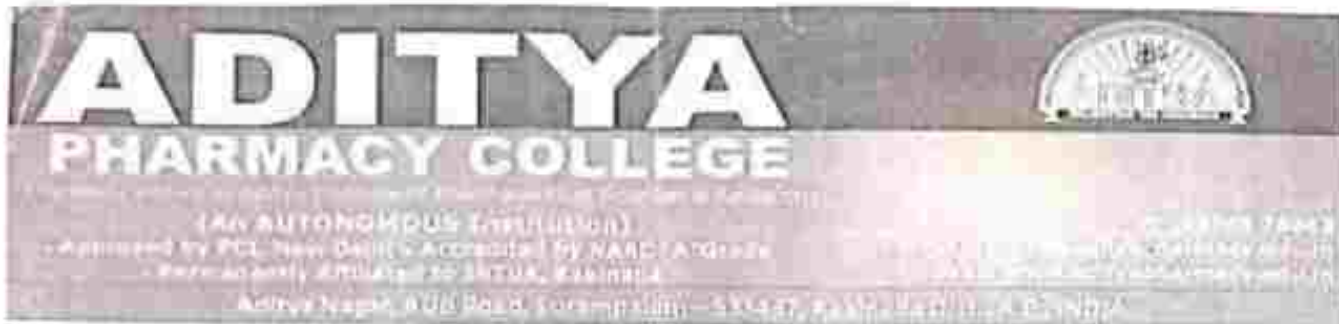
