An awareness program was conducted on "Zero Tolerance for Ragging: Foster a Safe Learning Environment" on 25-01-2025 at Seminar Hall for B. Pharmacy, Pharm. D & M. pharmacy Students. Around 102 students attend the seminar. The Programme began with the introduction of Chairman of Anti ragging committee Dr. D. Sathis Kumar. He emphasized the importance of maintaining a ragging-free environment and urged students to be vigilant and responsible. He reiterated that ragging has no place in the institution, as it goes against the very essence of education.

Mrs. Devi Avasarala, Panel Advocate, Prathipadu JCJ Court, was invited to speak about the definition of ragging and its various forms, Legal provisions under the Indian Penal Code (IPC) and the University Grants Commission (UGC) regulations. The speaker highlighted the consequences of ragging, including suspension, expulsion, and legal actions. Mrs. Devi Avasarala also explained the procedure for reporting ragging incidents, including anonymous complaints and the role of the Anti-Ragging Committee. The session was interactive, with students sharing their thoughts and experiences.

The Convener of Anti-Ragging Committee Mrs. G. Prasanthi addressed the students about psychological and emotional consequences of ragging. She explained how ragging could lead to long-term mental health issues, such as depression, anxiety, and even suicidal tendencies.

The program concluded with all participants taking a collective pledge to maintain a zero-tolerance stance on ragging and commit to upholding the values of respect, kindness, and inclusivity. The pledge emphasized the collective responsibility of students, faculty, and staff in creating a safe campus.

The awareness program on "Zero Tolerance for Ragging: Foster a Safe Learning Environment" at Aditya Pharmacy College was a success in spreading knowledge and encouraging positive behavioural changes. It reinforced the college's commitment to maintaining a ragging-free campus, ensuring that all students feel safe, supported, and respected during their academic journey.
